

**ORDINANCE NO. 2021-19**

**AN ORDINANCE AMENDING THE SUBDIVISION CONTROL ORDINANCE, SECTION 8.2 (A, 7, c) OF THE TOWN OF MARKLE, INDIANA,**

WHEREAS, the Town of Markle Plan Commission considered application MPC-21-016 filed by the Huntington Countywide Department of Community Development to amend Section 8.2 (A, 7, c) of the Subdivision Control Ordinance, Markle, Indiana; and,

WHEREAS, the Town of Markle Plan Commission conducted a duly noticed public hearing on application MPC-21-016 on May 12, 2021; and,

WHEREAS, the Town of Markle Plan Commission, by a 6-0 vote, issued a favorable recommendation to application MPC-21-016 at a meeting duly conducted on May 12, 2021. The Town of Markle Plan Commission Certification of the favorable recommendation is attached hereto and incorporated by reference as Exhibit "A", and,

WHEREAS, the Markle Town Council now determines that from time to time, it is necessary to amend land use regulations in accordance with IC 36-7-4-607; and,

WHEREAS, such regulations are designed to promote the public health, safety, general welfare, efficiency and economy in the process of the normal and orderly development of the land within the jurisdictional area.

NOW, THEREFORE, BE IT ORDAINED, BY THE MARKLE TOWN COUNCIL OF MARKLE, INDIANA, that the Town of Markle Subdivision Control Ordinance, Section 8.2 (A, 7, c) be amended and to read as follows:




