## **ORDINANCE NO. 2021-07**

AN ORDINANCE AMENDING THE SUBDIVISION CONTROL ORDINANCE, SECTION 11, A, 3 (MINOR SUBDIVISION-SUBMITTAL REQUIREMENTS) AND SECTION 13, A, 1 (MAJOR SUBDIVISION-SECONDARY PLAT SUBMITTAL REQUIREMENTS) OF THE TOWN OF MARKLE, INDIANA,

WHEREAS, the Markle Plan Commission considered application MPC-21-003 filed by the Huntington Countywide Department of Community Development to amend the Markle Subdivision Control Ordinance, Section 11, A, 3 (Minor Subdivision-Submittal Requirements) and Section 13, A, 1 (Major Subdivision-Secondary Plat Submittal Requirements) of the Town of Markle, Indiana; and,

NOW, THEREFORE, BE IT ORDAINED, BY THE MARKLE TOWN COUNCIL OF MARKLE, INDIANA, that the Markle Subdivision Control Ordinance, Section 11, A, 3 (Minor Subdivision-Submittal Requirements) and Section 13, A, 1 (Major Subdivision-Secondary Plat Submittal Requirements) be amended and to read as follows:
